

# **AGRO-BOOST**

An adjuvant to improve the efficacy of the herbicides listed.

### **ACTIVE INGREDIENT:**

Ammonium sulphate ..... 50% m/v

## PRECAUTIONS:

Do not inhale fumes or spray mist. Wash with soap and water after use and accidental skin contact. Do not eat, drink or smoke whilst mixing or applying, or before washing hands and face and changing clothes. **AGRO-BOOST** may be corrosive to metal parts of sprayers. Prevent contamination of food, feedstuffs, drinking water and eating utensils. Thoroughly wash and rinse spray equipment after use and dispose of wash water where it will not contaminate crops, grazing, rivers and dams.

When empty, invert the container over the spray tank or mixing tank and allow it to drain for at least 30 seconds after the flow has slowed down to a drip. Thereafter rinse the container three times with a volume of water equal to at least one tenth of that of the container and add the rinsings to the contents of the spray tank. Destroy the container by perforation and flattening and dispose of it in a safe way. Do not use the container for any other purpose

KEEP OUT OF THE REACH OF CHILDREN AND KEEP APART FROM FEEDS AND FOODSTUFFS.

# FIRST AID

**Inhalation:**: If breathed in, move person into fresh air. If not breathing, give artificial respiration. In case of discomfort seek medical attention.

Skin contact: None required

**Ingestion:** Do NOT induce vomiting. Never give anything by mouth to an unconscious person. Rinse mouth with water. Seek medical attention.

**Eye contact:** Flush eyes thoroughly with water for several minutes. Remove contact lenses after the initial 1-2 minutes and continue flushing for several additional minutes. Seek medical advice if symptoms persist.

There is no specific antidote. Treat symptomatically.

# **DIRECTIONS FOR USE: Use only as directed**

**AGRO-BOOST** is an aqueous solution that is suitable for all spray waters and spray equipment.

**AGRO-BOOST** complexes certain dissolved salts such as Calcium and Magnesium.

**AGRO-BOOST** improves the performance of the imidazolinone herbicides.

AGRO-BOOST is always tank mixed with the imidazolinone herbicides and applied as a post emergence application to weeds.

Use AGRO-BOOST at a rate of 2 % (volume / volume) of the spray mixture.

Ensure thorough coverage and wetting of the weeds, especially when crop foliage is dense.

The pH and hardness of the spray water may have a market effect on the performance of the glyphosate and sulphosate containing herbicides.

### Mixing instructions:

Fill the spray tank three-quarters with clean water. Measure the required volume of AGRO-BOOST and pre-mix this with at least 10 & water before adding to the spray tank. The other product(s) to be mixed with AGRO-BOOST should be pre-mixed in a similar fashion. Agitate the water in the spray tank and then first add the AGRO-BOOST followed by the other product(s). Fill the spray tank with water to the required level while maintaining agitation to ensure thorough mixing of the spray mixture before spraying commences. Maintain agitation while spraying. The prepared spray mixture must not be left in the spray tank for any length of time, e.g. overnight.

All spray applications must be made with suitable equipment that is in good working order and correctly calibrated to give the desired coverage for that particular method of application.

### Rate of application:

Mix 2 ℓ AGRO-BOOST per 100 ℓ water (2%)
